# MEMBERSHIP DUES 2010

SINGLE **\$125**

FAMILY **\$250**

Following are the guidelines for submitting your membership for 2010:

- Membership can only be received by the Secretary, MASOM, in-person only
- A prescribed MEMBERSHIP FORM is REQUIRED to be filled out completely (incomplete forms will not be accepted)
- Membership Forms must be filled out in BLOCK LETTERS only (if the handwriting is not legible, we would ask the form to be re-submitted)
- State ID is required for verification purposes only
- Renewal applications must be submitted between Jan-1-2010 and Jan-31-2010
- Renewal applications received after Jan-31-2010 must be accompanied by a letter of appeal explaining the reason for a late submittal, as per Article IV (1) below:

### **Article IV**

1. All annual dues shall be payable on or before January 31st of each year. Non-payment of dues will result in cancellation of membership and withdrawal of membership privileges. A member in good standing who fails to pay due to unavoidable circumstances may appeal his case in writing to the Executive Committee within ninety (90) days from the expiration date of his membership for continuation of privileges. Decision of the Executive Committee shall be final in this matter.

- ALL applications will be reviewed by the MASOM Executive Committee, and appropriate action will be taken as per MASOM By-laws.
- Final decision will be communicated to the applicant via the preferred method of communication selected in the application.
